Introduction

At Lulworth Investment Partners, we believe in being transparent about how we collect and use your data. This policy provides detailed information about how and why we use cookies on our website. As a UK authorised and regulated investment management firm, we use cookies not only to improve your browsing experience but also to ensure we meet our regulatory obligations regarding the distribution of financial information.

Understanding Cookies

Cookies are small text files that are placed on your computer or mobile device by websites that you visit. They are widely used to make websites work more efficiently, as well as to provide information to the owners of the site.

Categories of Cookies We Use

We use the following types of cookies to manage our website:

- **Strictly Necessary Cookies:** These are essential for the operation of our website. They include, for example, cookies that enable you to navigate the site, use secure areas, or remember your investor classification (e.g. Retail or Professional) so that we display only the information legally permitted for your category.
- **Performance and Analytical Cookies:** These allow us to recognise and count the number of visitors and to see how visitors move around our website when they are using it. This helps us to improve the way our website works, for example, by ensuring that users are finding what they are looking for easily.
- **Marketing Cookies:** These record your visit to our website, the pages you have visited, and the links you have followed. We use this information to make our website and the advertising displayed on other platforms (such as LinkedIn or Google) more relevant to your interests.

The Cookies We Use

Based on our current platform (Wix), the following cookies are utilised on this site:

Strictly Necessary Cookies

These are required for the administration and security of our site and cannot be switched off.
